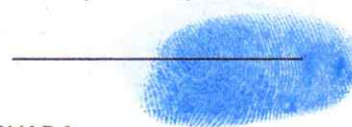

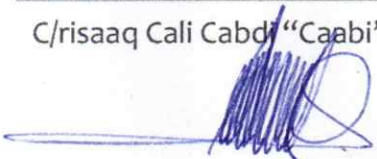


**SUGITAANKA MAXKAMADDA.**

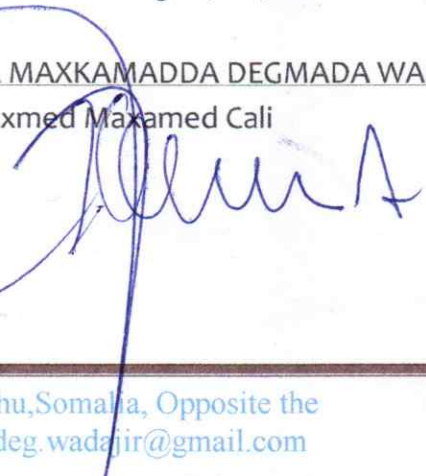
